CONTRACT OF CONSULTANCY SERVICES

THIS CONTRACT made this 15th day of June 2022 in Page 15th Philippines, by and between:

The **DEPARTMENT OF EDUCATION**, a government agency duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal address at DepEd Complex, Meralco Avenue, Pasig City, herein represented by **ATTY. ALBERTO T. ESCOBARTE**, **CESO II**, Assistant Secretary for Legislative Affairs, as per DepEd Order No. 008, s. 2021, as amended by DepEd Order No. 023, s. 2021, hereinafter referred to as "**DEPED**"; and **ATTY. JOSE MARI O. MOLINTAS**, of legal age, Filipino, and with address at Room 305 & 306, Jose Miguel Building, No. Yandoc St., cor. Labsan St., Kayang Extension, Baguio City, Philippines, hereinafter referred to as "**CONSULTANT**";

WHEREAS, under Section 53.7 of the Republic Act (R.A.) 9184 and its revised Implementing Rules and Regulations (IRR), negotiated procurement for Highly Technical Consultant may be resorted to in the case of individual consultants hired or engaged to do work that is highly technical or proprietary;

WHEREAS, the **DEPED**, through the Legal Division-Office of the Director, pursuant to the approved Resolution to Engage Consultant NO. 2022c-LS3(001)-BIV-NPHTC-005 dated 27 April 2022, engages the services of the **CONSULTANT**.

NOW, THEREFORE, PREMISES CONSIDERED, the parties hereby agree as follows:

1. CONTRACT DOCUMENTS

The following documents shall be deemed to form and be read and construed as part of this Contract, viz:

- Resolution to Engage Consultant No. 2022c-LS3(001)-BIV-NPHTC-005 dated 27 April 2022 and all its attachments;
- ii. Notice of Award; and
- iii. Terms of Reference.



2. DURATION OF ENGAGEMENT

This Contract shall be binding and in effect for SIX (6) MONTHS. The commencement of the period will be determined by the parties after signing of this Contract. Extension of the Contract period may be allowed on justifiable grounds as determined by and/or subject to the approval of **DEPED**, provided that there shall be no additional expense to **DEPED** other than what is stipulated in this Contract.

3. TERMS OF REFERENCE

The **CONSULTANT** shall execute the following duties and responsibilities:

- a. Review contracts and other memoranda involving Civil, Administrative, Intellectual Property, International, Human/Child Rights, and Education Laws;
- b. Assist in the preparation of documents pertaining to, and/or related to Civil, Administrative, Intellectual Property, International, Human/Child Rights, and Education Laws;
- c. Draft and recommend legal opinion, review, and other appropriate actions on matters involving Civil, Administrative, Intellectual Property, International, matters involving Civil, Administrative, intellectual Property, International, Human/Child Rights, and Education Laws;
- d. Assist in the arbitration and/or litigation disputes involving Civil, Administrative, intellectual Property, International, Human/Child Rights, and Education Laws;
- e. Assist in the preparation of pleadings or documents necessary in any related case or matter;
- f. Assist in coordinating with the Office of the Solicitor General for cases that are pending or will be filed with the court of competent jurisdiction;
- g. Train, coach, mentor, legal officers and personnel on how to effectively evaluate and process various legal documents involving Civil, Administrative, Intellectual Property, International, Human/Child Rights, and Education Laws; and
- h. Perform related tasks and other legal functions which may be assigned by the Undersecretary, Assistant Secretary for Legal Affairs, or the Director of Legal Service.

4. PAYMENT

DEPED shall pay, subject to existing disbursement, accounting and auditing rules and procedures, the services of the **CONSULTANT** in the

total amount of PHILIPPINE PESOS TWO HUNDRED TEN THOUSAND (Php210,000.00), inclusive of VAT, detailed as follows:

Payment shall be disbursed in six (6) tranches subject to submission of accomplishment reports and/or outputs in accordance with the Output Schedule/Deliverables and Payment Schedule as provided under the Terms of Reference.

5. INTELLECTUAL PROPERTY RIGHTS

All deliverables, studies, reports or other materials prepared by the CONSULTANT for DEPED under this Contract shall be owned by and remain the exclusive property of DEPED and shall not be used for any purpose other than what is stipulated under this Contract. Immediately upon completion or termination of this Contract, the CONSULTANT shall surrender all copies, files, materials, records, notes, other written, printed, tangible or intangible materials (soft and hard copies), and any other property in the CONSULTANT's possession that belong or relate to the interest of DEPED.

6. CONFIDENTIALITY

The CONSULTANT acknowledges that this Contract is dependent on the trust and confidence reposed on him or her by DEPED. The CONSULTANT also acknowledges that, in the course of carrying out his or her duties and responsibilities under this Contract, he or she may receive, be furnished with, or become privy to confidential matters concerning the transactions of DEPED and/or sensitive discussions with or between DEPED official (the "Confidential Information"). The CONSULTANT shall not use any Confidential Information acquired during the term of this contract for his or her own benefits.

7. EMPLOYER-EMPLOYEE RELATIONSHIP

It is understood that this Contract does not create an employer-employee relationship between **DEPED** and the **CONSULTANT**; that the services rendered hereunder by the **CONSULTANT** are not considered and will

not be credited as government service; and that the **CONSULTANT** is not entitled to benefits enjoyed by regular personnel of **DEPED**, unless otherwise provided by law.

8. LIQUIDATED DAMAGES

If the **CONSULTANT** fails to satisfactorily render his or her services within the period(s) specified in the Contract inclusive of duly granted time extensions if any, **DEPED** will, without prejudice to its other remedies under the Contract and under the applicable law, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one (1) percent of the cost of the unperformed portion for every day of delay until actual performance. The threshold for the accumulated deduction will be ten percent (10%) of the amount of Contract Price. Once the maximum is reached, the **DEPED** may rescind or terminate the Contract, without prejudice to other courses of action and remedies open to it.

9. SETTLEMENT OF DISPUTES

The Parties shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the parties in connection with the implementation of the Agreement. Should such dispute not be resolved amicably, it shall be submitted to arbitration in the Philippines, with the Philippines as the seat of arbitration according to the provision of R.A. 876, otherwise known as the "Arbitration Law" and R.A. 9285, otherwise known as the "Alternative Dispute Resolution Act of 2004." Provided, however, that by mutual agreement, the parties may agree in writing to resort to other alternative modes of dispute resolution.
