CONTRACT

THIS CONTRACT made and entered into this JUN 03 2022 day of _____ 2022 by and between **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, Philippines, represented herein by its Undersecretary for Administration, **ALAIN DEL B. PASCUA** as per Department Order No. 023, s. 2021 (hereinafter referred to as "DEPED"); and **REDDOT IMAGING PHILIPPINES, INC.**, represented herein by its Authorized Representative, **JOAN A. ONGONION**, with office address at 1817-1825 España corner Prudencio St., Sampaloc, Manila, Philippines, (hereinafter referred to as "REDDOT IMAGING").

DEPED and REDDOT IMAGING are collectively called "PARTIES."

WHEREAS, the Parties entered into a contract agreement on December 3, 2021, herein referred to as the "Original Contract" for the supply, delivery and maintenance of DCP Packages;

WHEREAS, pursuant to Section 51 of the Revised Implementing Rules and Regulations of RA 9184, Repeat Order is allowed as a method of procurement of goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding;

WHEREAS, the repeat order does not result in splitting of contracts; the repeat order is availed of within six (6) months from the date of the Notice to Proceed arising from the Original Contract; the repeat order does not exceed twenty-five percent (25%) of the quantity of each item in the Original Contract;

WHEREAS, **REDDOT IMAGING PHILIPPINES, INC.** submitted its quotation for Lot Number 8 which is equal to the unit price under the Original Contract;

WHEREAS, **DEPED**, through its Bids and Awards Committee II resolved to recommend the award of the contract for Lot No. 8 to **REDDOT IMAGING PHILIPPINES, INC.** in the sum of **PHILIPPINE PESOS SEVENTY MILLION, NINE HUNDRED NINETY-FIVE THOUSAND, EIGHT HUNDRED TWENTY-FIVE & 00/100 (Php 70,995,825.00) ONLY**, (hereinafter called the "Contract Price") detailed as follows:



1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
 - i. Philippine Bidding Documents (PBD):
 - a. Schedule of Requirements;
 - b. Technical Specifications;
 - c. General and Special Conditions of the Contract.
 - ii. Contract No. 2022c-ICTS3(014to015)-BII-RO-011;
 - iii. REDDOT IMAGING PHILIPPINES, INC.'s quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted under the original contract;
 - iv. Performance Security of the Original Contract;
 - v. Notice of Award of Contract and REDDOT IMAGING PHILIPPINES, INC.'s conforme thereto; and
 - vi. Other contract documents required by existing laws and/or DepEd in the PBD. REDDOT IMAGING PHILIPPINES, INC. agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Order, and Warranty Security, shall form part of the Contract.
3. The Contract shall be performed in accordance with the delivery schedules indicated in the Notice to Proceed (NTP), or in any subsequent instruction duly issued by DEPED.

4. The goods should conform to the Technical Specifications of the approved samples that were submitted and evaluated during the post-qualification stage of the procurement, a copy of which is hereto attached as **Annex "A"** and made an integral part hereof. Any proposal to deliver items of equivalent, higher or superior technical specifications, in lieu of the above stated, shall be discretionary to **DEPED** and is subject to the evaluation and recommendation of the end-user or implementing units and the approval of the herein authorized representative and signatory.
5. Goods with defects or non-compliant with the required specifications shall be rejected by **DEPED** and replaced by **REDDOT IMAGING PHILIPPINES, INC.** shall have the option to inspect **REDDOT IMAGING PHILIPPINES, INC.**'s premises covered by the contract, at any time or stage of contract implementation, to monitor and assess **REDDOT IMAGING PHILIPPINES, INC.**'s capacity to discharge its contractual obligations.
6. In case **REDDOT IMAGING PHILIPPINES, INC.** encounters condition(s) impeding timely delivery of the goods, **REDDOT IMAGING PHILIPPINES, INC.** shall promptly notify **DEPED** in writing of such condition(s) and any request for work suspension and/or contract delivery period extension shall be promptly done in writing as soon as circumstances providing justification for such requests have become apparent. **REDDOT IMAGING PHILIPPINES, INC.** must provide sufficient proof to support any request for work suspension and/or contract delivery period extension.
7. The Contract Price shall be paid to **REDDOT IMAGING PHILIPPINES, INC.** in accordance with the following disbursement procedures:
 - 8.1. Upon submission of an irrevocable letter of credit or Bank Guarantee issued by a Universal or Commercial Bank, advance payment not to exceed fifteen percent (15%) of the contract amount shall be allowed and paid within sixty (60) calendar days from signing of the contract;
 - 8.2. **REDDOT IMAGING PHILIPPINES, INC.** may submit a request for payment based on the monthly Progress Reports which shall be attached to the progress billing and include the following: (i) cumulative quantities of items delivered based on the schedule of delivery and other relevant terms and conditions of the contract; (ii) Inspection and Acceptance Reports, including certification by **REDDOT IMAGING PHILIPPINES, INC.** as approved by the duly authorized representative of **DEPED**, that the items have been delivered. Other documents in support of a request for payment may be prescribed by **DEPED** pursuant to

existing disbursement, accounting and auditing rules and procedures;

8.3. Subject to the recoupment of the advance payment contemplated in Clause 8.1 above, and retention contemplated in the immediately succeeding clause, payment shall be made to **REDDOT IMAGING PHILIPPINES, INC.** as promptly as possible after the date of acceptance of Goods at **REDDOT IMAGING PHILIPPINES, INC.'s** warehouse and upon submission of the documents specified in SCC Clause 2.2 and other documents as may be prescribed by DepEd, in the following manner:

8.3.i. For the initial progress payment, a minimum of 25% of the Contract Price of this lot shall be paid to **REDDOT IMAGING PHILIPPINES, INC.** upon a minimum of 25% delivery of the requirement of this lot and duly accepted by **DEPED's** authorized representative;

8.3.ii. Final payment shall constitute release of the retention money in case of expiry of the warranty period, or whatever is left of it, after it has been called for use under the warranty provision.

9. Payments shall be subject to the "Warranty" provision in the form of either retention money in an amount equivalent to at least three percent (3%) of every progress payment, or a Special Bank Guarantee in the amount equal to at least three percent (3%) of the Contract Price as required under Section 62 of R.A. 9184 and its revised IRR.

9.1. A comprehensive and on-site warranty of three (3) years shall be applied to Laptop and External Hard Drive which shall reckon from the date of issuance of Certificate of Final Acceptance by **DEPED**.

9.2. A standard/base warranty or minimum of one (1) year warranty shall be applied to Laptop Batteries, Optimal Mouse and Keyboards for Laptops and Laptop Headsets.

10. **REDDOT IMAGING PHILIPPINES, INC.** shall be liable for liquidated damages for the delay in its performance of the Contract in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery for every day of delay until such goods are finally delivered and accepted by the **DEPED's** authorized representative.


DEPED shall deduct the liquidated damages from any money due or which may become due to REDDOT IMAGING PHILIPPINES, INC. or collect from any of the securities or warranties posted by the REDDOT IMAGING PHILIPPINES, INC. whichever is convenient to DEPED. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the Contract Price, DEPED may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.

11. The Parties shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the parties in connection with the implementation of the Agreement. Should such dispute not be resolved amicably, it shall be submitted to arbitration in the Philippines according to the provisions of Presidential Decree No. 242 and Executive Order No. 292. Provided, however, that by mutual agreement, the parties may agree in writing to resort to other alternative modes of dispute resolution.

- Supplier shall set up and manage Helpdesk Support that shall accommodate and process all queries and troubleshooting calls within applicable business hours and business days.
- Supplier shall accommodate and process the recipient's immediate technical support for both hardware and software. Inquiries coming from the emails, phone calls, letters and SMS from different Telco's coming from the recipient school are considered official communication modes and shall be addressed accordingly.

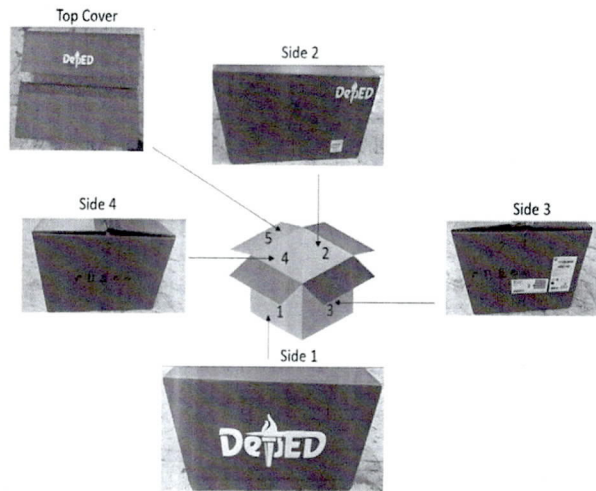
