The **Department of Education (DepEd)**, through the Government of the Philippines (GOP) under **FY 2022 NASBE (Current Funds)**, intends to apply the sum of **Philippine Pesos One Million, Five Hundred Twenty-Seven Thousand, Eight Hundred Fifty-Four and 27/100 (PhP1,527,854.27)**, being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Test Materials for Educational Management Test-Rebid,** broken down in lots as follows:

2. The **DepEd**, through the **Bids and Awards Committee (BAC) IV**, now invites bids for the goods and services contemplated in this project and as detailed in the

Schedule of Requirements and the table of Technical Specifications indicated in the bidding documents. The expected completion of delivery of the goods is within the specified dates stipulated in the Section IV, Schedule of Requirements.

Prospective bidder should have completed, within a period of *five (5) years* immediately preceding the deadline for submission of bids, Single Largest Completed Contract (SLCC) similar to the contract to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority (PSA) consumer price index, must be at least twenty-five percent (25%) of the ABC of the lot bid for; OR have completed, within a period of five (5) years immediately preceding the deadline for submission of bids, at least two (2) similar contracts and the total of the aggregated contract amount should be equivalent to at least twenty-five percent (25%) of the ABC of the lot/s bid for; and the largest of these similar contracts must be equivalent to at least 12.5% of the ABC of the lot/s to be bid.

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 5. For those who are interested to purchase the Bidding Documents, two (2) options are made available, to wit:

b. - 7. Bids must be duly received by the BAC Secretariat on or before 12:30 P.M. of December 9, 2022 at Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Ave., Pasig City.

Late bids shall not be accepted.

- All Bids must be accompanied by a bid security in any of the acceptable forms 8. and in the amount stated in ITB Clause 14.
- Bid opening shall be on December 9, 2022, 1:00 P.M. at Bulwagan ng 9. Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Ave., Pasig City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

For the purpose of constituting a quorum, both the physical and virtual presence of the BAC members shall be considered pursuant to GPPB Resolution No. 09-2020.
