WHEREAS, the Department of Education (DepEd), through the Bureau of Learning Resources – Learning Resources Production Division (BLR-LRPD), is in need of service provider/s for **Procurement of Printing and Delivery of Reading Materials**, with a total approved budget for the contract (ABC) in the amount of **Philippine Pesos Five Hundred Eleven Million, Ninety-Seven Thousand, Forty-Nine and 26/100 (Php511,097,049.26)**, broken down in lots:

WHEREAS, on November 25, 2022, the BAC convened and discussed the letter from the end-user recommending the cancellation of the project; copies of the letter from the end-user dated November 23, 2022 and Minutes of BAC Meeting are attached and marked as Annex "G";
