4. Section III. Bid Data Sheet, Item 14.1, page 18, is hereby amended to be read as follows:

> "The bid security shall be in the form of a Bid Securing Declaration, or any of the following forms and amounts:

- a. The amount of not less than Php289,210.68, if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit; or
- b. The amount of not less than Php723,026.70, if bid security is in Surety Bond."
- 5. Section III. Bid Data Sheet, Item 20.1, page 21 is hereby amended to be read as follows:
