CONTRACT

THIS CONTRACT made and entered into this 130 day of MAR 2023 by and between the **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, Philippines, represented herein by its Undersecretary, **GLORIA JUMAMIL-MERCADO**, as per Department Order No. 001, s. 2023 and Office Order OO-OSEC-2023-60 (hereinafter referred to as "**DEPED**"); and **FIRST DATACORP**, represented herein by its Sales Team Lead, **SHEREE LYN B. LEPAOPAO**, with office address at 3/F Citibank Center, 8741 Paseo de Roxas, Makati City, Philippines (hereinafter referred to as "**FIRST DATACORP**"), as per Secretary's Certificate dated 27 January 2023 (hereto attached as Annex "A").

DEPED and FIRST DATACORP are collectively called "PARTIES."

WHEREAS, DEPED invited bids for the subscription for new digital arts and multimedia tools, and received a bid from a lone bidder (**FIRST DATACORP**); **DEPED** opened, read, and evaluated the bid of **FIRST DATACORP** and declared **FIRST DATACORP** as having the Single Calculated Bid for the project; after evaluation, **DEPED** post-qualified and declared the bid of **FIRST DATACORP** as the Single Calculated Responsive Bid in the sum of **PHILIPPINE PESOS TWO HUNDRED EIGHTY-FIVE MILLION, NINE HUNDRED SEVENTY-NINE THOUSAND, TWO HUNDRED THIRTY-TWO and 00/100 (PhP285,979,232.00) ONLY**, (hereinafter called the "Contract Price") detailed as follows:

- b. **FIRST DATACORP's** bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- c. Performance Security;
- d. Notice of Award of Contract and **FIRST DATACORP's** conforme thereto; and
- e. Other contract documents required by existing laws and/or DepEd in the PBD. **FIRST DATACORP** agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Order, and Warranty Security, shall form part of the Contract.

3. **FIRST DATACORP** shall post a Performance Security within ten (10) calendar days from receipt of the Notice of Award in the form and amount prescribed therein. The performance security shall be posted in favor of **DEPED**, and shall be forfeited in the event it is established that **FIRST DATACORP** is in default of any of its obligations under this contract. **FIRST DATACORP** shall be responsible for the extension of its performance security and/or undertake to renew its performance security whenever necessary, and without need of prior notice or instruction from the **DEPED**, to ensure that it is in force and effect for the whole duration of the contract and until a Certificate of Final Acceptance is duly issued.

4. **FIRST DATACORP** shall provide **DEPED** the access to the administration portal with the licenses and transaction credits within **SEVEN (7) CALENDAR DAYS** from the date of receipt of the Notice to Proceed. The one-year duration of the subscription license does not refer to the duration of this Contract.

FIRST DATACORP shall ensure that the services will be rendered in accordance with the Schedule of Requirements, which is hereto attached as Annex "B" and made an integral part hereof.

5. **FIRST DATACORP** shall render services at the DepEd Central Office, DepEd Complex, Meralco Avenue, Pasig City. Services rendered at sites other than the DepEd Central Office without **DEPED's** written authorization and/or approval may be rejected by the latter. Violation of this Contract, its Schedule of Requirements, Terms of Reference, Post-qualification, and other documents and reports submitted and validated by the authorized receiving personnel may be cause for the termination of the Contract.

6. The services to be rendered by **FIRST DATACORP** must conform to and comply with the standards mentioned in Section VI. Schedule of Requirements of the Bidding Documents, and the Terms of Reference and final technical specifications as approved by the Bids and Awards Committee based on the actual offer of **FIRST DATACORP** and reflected in the post-qualification report, which is hereto attached as Annex "C" and made an integral part hereof.

Any proposal by **FIRST DATACORP** to deliver items of different technical specifications, in lieu of those of the approved bids, shall not be allowed. However, under justifiable circumstances, i.e. fortuitous events, force majeure, acts of God, public state emergency, or those defined under the Civil Code and other similar circumstances, delivery of items of equivalent, higher or superior technical specifications may be permitted, subject to the evaluation and favorable recommendation of the **DEPED's** end-user or implementing unit, and the approval of the herein authorized signatory. In any such case, the proposal by **FIRST DATACORP** for substitution shall be in writing and shall not result in any additional cost or undue burden to **DEPED**.

7. A one-year technical support and webinar for onboarding is included in the procured subscription license.

8. In case **FIRST DATACORP** encounters condition(s) impeding timely completion of services, **FIRST DATACORP** shall promptly notify **DEPED** in writing within **five (5) calendar days** from notice of such condition(s). Any request for work suspension and/or contract period extension shall be promptly done in writing as soon as circumstances for such request have become apparent. **FIRST DATACORP** must provide sufficient proof to support any request for work suspension and/or contract period extension.

9. The Contract Price shall be paid to **FIRST DATACORP** in accordance with the following disbursement procedures:

- a. **FIRST DATACORP** may submit a request for payment based on the following:
 - i. Value of actual services rendered based on the terms of reference and other relevant terms and conditions of the Contract; and,
 - ii. Certification by **FIRST DATACORP**, as approved by the duly authorized DepEd representative, that the services have been rendered in accordance with the Contract, Schedule of Requirements, Terms of Reference and Post-qualification.

12. **FIRST DATACORP** shall be liable for liquidated damages in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion, for every day of delay. **DEPED** shall deduct the liquidated damages from any money due or which may become due to **FIRST DATACORP**, or collect from any of the securities posted by **FIRST DATACORP**, whichever is convenient to **DEPED**. Once the accumulated amount of liquidated damages reaches ten percent (10%) of the Contract Price, **DEPED** may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.

- Allows each user to activate all the applications in desktops/laptops, mobile, and web on up to two devices (or virtual machines) simultaneously.
