PHILIPPINE FOUNDATION FOR SCIENCE AND TECHNOLOGY PROGRAMS
AND PROJECTS FOR SCHOOL YEAR 2018–2019

The Philippine Foundation for Science and Technology (PFST) has designed the following programs and projects for School Year 2018–2019 to promote Science and Technology consciousness among the youth and various sectors of society:

1. Philippine Science Centrum (PSC). A combination of a science center and museum featuring over 100 interactive and hands-on exhibits.
2. Philippine Science Centrum-Traveling Exhibitions such as: (a) Science Adventures, (b) Sci-Fun Caravan, (c) Science on the Move, (d) Science Works!, (e) Science Sparks, (f) Health Science on the Go, and (g) Mobile Science. These traveling science exhibitions featuring replicas of PSC interactive exhibits primarily aim to reach other learners audiences, who could not benefit from permanent exhibits at PSC due to distance and other cost constraints;
3. Training, Seminars and Workshops for Teachers. These activities for science teachers, either in the elementary or secondary level, such as (a) Hands-on Minds-on Micro scale Chemistry Workshop, (b) Teachers Science Camp, and (c) Start Kits, introduce interactive and integrative approaches/strategies in teaching science-related subjects.
4. Science Centrum Fabrication. This is an exhibit fabrication unit of PFST for interactive exhibits with the technical capability of developing, prototyping, fabricating and/or manufacturing interactive exhibits and other educational paraphernalia for the promotion and development of science and technology.

The target participants are learners, teachers and school administrators from public and private schools.

Participation of public and private schools shall be subject to the no-disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2005 entitled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith as well as DepEd Order No. 66, s. 2017 entitled Implementing Guidelines on the Conduct of Off-Campus Activities. This is also subject to the no-collection policy as stated in Section 3 of Republic Act No. 5546, An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law).
