1. The **Department of Education (DepEd)**, through the Government of the Philippines (GOP) under 2023-LTE-TVL (Continuing Fund) intends to apply the sum of Philippine Pesos Seven Million, Nine Hundred Twenty-Eight Thousand, Seven Hundred Ninety-Two and 16/100 (PhP7,928,792.16) only, being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Freight, Handling, and Forwarding Services for the Delivery of procured TVL Tools and Equipment utilizing the FY 2022 Funds stored at Nikka **Trading's Warehouses** broken down as follows:

Expected completion of delivery of the goods/services is specified in Section VI. Schedule of Requirements and Section VII. Technical Specifications of the Bidding Documents.

Prospective bidder should have completed, within a period of **ten (10) years** immediately preceding the deadline for submission of bids, Single Largest Completed Contract (SLCC) similar to the contract to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority's (PSA's) Consumer Price Index (CPI), must be **at least fifty percent (50%)** of the ABC.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Upon receipt of the bidder's information sheet, the BAC Secretariat Division will send through email the details of the DECS OSEC Trust Fund Account for payment. Upon payment, bidders may send through email the proof of payment before the deadline for submission of bids. Upon receipt of proof of payment, the BAC Secretariat will send the electronic copy of the Bidding Documents.

Amount of Bidding Documents shall be Philippine Pesos Ten Thousand and 00/100 (PhP10,000.00).

- 6. The *DepEd* will hold a Pre-bid Conference for this Project on **April 23**, **2024**, **2:00** p.m. at **Bulwagan ng Karunungan**, **Ground Floor**, **Rizal Building**, **DepEd Complex**, **Meralco Ave.**, **Pasig City**, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before 2:00 p.m. (Philippine Standard Time) of May 6, 2024 at Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Ave., Pasig City. Bids will be opened, immediately after the aformentioned deadline for receipt of bids, in the presence of the bidders' representatives who choose to attend the activity.

Late bids shall not be accepted.

Only **two (2) representatives** per bidder will be allowed to enter inside the venue.

For the purpose of constituting a quorum, both the physical and virtual presence of the BAC members shall be considered pursuant to GPPB Resolution No. 09-2020.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. The **DepEd** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
